Your documents must be sent using a secure, trackable method and in secure packaging. Documents may also be hand delivered to our reception during open hours only. As we deal with sensitive information and documents, entry into our main office, completing your documents on site or using our computers or equipment is not allowed. For this reason, you must bring your documents completed for the handover on delivery. If you require advice on hand delivery, please call or email us to book an appointment to see a specialist before you arrive and ensure all documents are completed to the best of your ability beforehand. We will not provide assistance with documents in our reception without a prior appointment. Appointments are daily between 11am and 3pm.   - **For the family visit visa, you must supply an invitation letter from the family member being visited that has the approval stamp of the Immigration Authority of Mongolia. The letter must be supplied with a copy of the passport ID page, Mongolian visa and evidence of your relationship.**
